WHAT DOESTMH FEDERAL CREDIT UNION DO WITH YOUR PERSONAL INFORMATION?

Why? Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What? The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- · Social Security Number and Name
- Account Balances and Payment History
- Creditworthiness and Credit History

When you are no longer our member, we continue to share information about you according to our policies.

How? All financial companies need to share members' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their **members'** personal information; the reasons **TMH** Federal Credit Union chooses to share; and whether you can limit this sharing.

How does TMH FCU protect my personal information?

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

How does TMH FCU collect my personal information?

We collect your personal information, for example, when you

- open an account or deposit money
- pay your bills or apply for a loan
- · use your credit or debit card

We also collect your personal information from other companies.

Why can't I limit all sharing?

Federal law gives you the right to limit only

- sharing for affiliates' everyday business purpose information about your creditworthiness.
- affiliates from using your information to market to you.
- · sharing for non affiliated to market to you.

State laws and individual companies may give you additional rights to limit sharing.

DEFINITIONS:

Affiliates Companies related by common ownership or control.

They can be financial and nonfinancial companies.

TMH FCU has no affiliates.

Non Affiliates Companies not related by common ownership or control. They can be financial and nonfinancial companies.

TMH FCU does not share with non affiliates so they can

market to you.

A formal agreement between non affiliated financial companies Joint Marketing

that together market financial products or services to you.








Be Prepared for Your Next Auto Purchase

Chipped Credit Cards

TMH Federal Credit Union members will soon be able to use their credit cards in stores with an additional layer of protection against fraud in the form of a small microchip embedded in their card. Due to significant increases in fraud, YOUR Healthcare Credit Union is upgrading its credit card security systems in an effort to fight skyrocketing fraud costs. While federal regulations already protect our members from liability for most fraudulent transactions, the process is frustrating and concerning.

That's why TMH FCU is making the switch to EMV (Europay, MasterCard, and Visa) cards, which contain computer chips that authorize or validate payment-card transactions. Soon when your card expires you will receive a replacement card with the EMV technology.
